Minutes

Anson County Board of Education Monday, April 28, 2025, 5:00 p.m. Regular Meeting Anson County Schools' Administrative Board Room

The Anson County Board of Education met in a regular session on Monday, April 28, 2025. Board members present were Marilynn Bennett, Lisa Davis, Carol Gibson, Frank Liles, Bobbie Little, Judy Little, Kelly Sheppard, and George Truman. Beulah Pratt arrived at 5:18 p.m. Others in attendance were Dr. Brian Ratliff (Superintendent), Dr. Josh McLaurin (Executive Administrator), Mike Flake (Board Attorney), and Anne Hyatt (Board Clerk).

Call to Order

Dr. George Truman called the meeting to order at 5:00 p.m. and welcomed everyone.

Invocation

Frank Liles gave the Invocation.

Adopt Agenda

The board voted to adopt the agenda as presented with a motion by Marilynn Bennett, seconded by Bobbie Little. The motion carried.

Approve Minutes

Frank Liles moved to approve the meeting minutes of March 31, 2025, and the Budget Development Workshop of April 14, 2025. Carol Gibson seconded the motion, which was approved by the board and carried.

Closed Session

Chair Truman asked for a motion to go into a closed session to consider a personnel action that involves an officer or employee of the Board pursuant to North Carolina General Statute 143.318.11 (a)(6) and to discuss the acquisition of real estate or to discuss the price and other material terms of a contract or proposed contract for the acquisition of real property according to North Carolina General Statute 143.318.11(a)(5). Lisa Davis made a motion to go into closed session at 5:03 p.m. The motion was seconded by Frank Liles and approved by the board. Motion carried.

Reconvene Open Session

The Board returned to open session at 5:52 p.m. upon a motion by Lisa Davis. Carol Gibson seconded the motion, which was approved by the board and carried.

Chair's Report

Corey Ross provided an update about the entrance and exit at Anson High School and Anson Middle School. Mr. Ross stated that he has had conversations since the last meeting with the Department of Transportation (DOT). He explained that the DOT has agreed to revisit the 2019 plan versus the 2024 plan to see if there are any further recommendations that could help with traffic flow. Mr. Ross mentioned that a meeting should be held soon and that he will share updates afterward.

Lisa Davis told the public comment speaker, Ms. Kendall, to please reach out to the superintendent to share her concerns, and she thanked the speaker for attending the meeting.

Superintendent's Report

Lisa Davis motioned to approve the consent agenda items (Proposed Budget for 2025-2026 and the 2024-2025 School Year Re-Administration Program Plan). The motion was seconded by Frank Liles and approved by the board. Motion carried.

New Business

Upon a motion by Lisa Davis, seconded by Judy Little, the board approved the personnel report A-1 through I-9, with I-9 being approved for four years instead of two years and to table I-10 through I-17. Motion carried.
