# Minutes Anson County Board of Education Regular Meeting Monday, August 31, 2009, 5:30 p.m.

The Anson County Board of Education met in regular session Monday, August 31, 2009. All members were present except for an excused absence from Altheria Patton and Rob Rollins. Others in attendance were Frances Williamson (Deputy Superintendent), Michael Freeman (Executive Director), Michael McLeod (Executive Director for Individual and Organizational Accountability), Mike Flake (Board Attorney), and Anne Hyatt (Clerk to the Board of Education).

#### I. Call to Order

Board Chairperson Lisa Davis opened the meeting and welcomed all visitors.

#### **Regular Meeting**

## VIII. Chair's Report

- Raleigh Dingman Award Nomination: Russell Sikes made a motion to nominate Dr. Altheria Patton for the Raleigh Dingman Award (if she is willing to accept the nomination). The motion was seconded by Michael Livingston and unanimously approved. Motion carried. In a memo from The NC School Boards' Association, the prestigious Raleigh Dingman Award will be presented during the Awards Ceremony of the Annual Conference on Tuesday, November 17, 2009, at the Sheraton/Koury Convention Center in Greensboro. The Raleigh Dingman winner serves as an ex officio member of the State Board of Education and represents NCSBA and the 115 local boards of education.
- NCSBA County Commissioners Award: Daniel Wilson made a motion to nominate the Anson County Board of County Commissioners for the NC School Boards' Association (NCSBA) County Commissioners Award. The NCSBA states this award recognizes a board of county commissioners for service to the local community through outstanding support of public elementary and secondary education. This award will be presented at the Awards Ceremony at the annual conference in November. The chairman of the recipient board of county commissioners will be invited to accept the award. Mr. Wilson praised the Board of County Commissioners for their outstanding support of the school system. This motion was seconded by Leon Gatewood. Motion carried.
- United Way: Dr. Firn explained that he is the current chair of the United Way campaign and asked for support from the members. He said this is a way the board could show support for the community. He stated that Anne Hyatt will furnish each member with a pledge form if they are interested in donating to the United Way.
