# Minutes Anson County Board of Education Regular Meeting Monday, January 28, 2008, 5:30 p.m.

The Anson County Board of Education met in regular session Monday, January 28, 2008. All members were present except for an excused absence by Dr. Altheria Patton.

- State of the District (A Mid-Year Report) Dr. Firn distributed a mid-year report to members and asked that they let him know if they have any concerns or questions. Dr. Firn explained that he will follow-up with any concerns at the February Board Meeting.
- Make Your Day (MYD) Presentation by Anson Middle School Mr. Owens (Assistant Principal) introduced Anson Middle Schools' MYD CATS committee. The committee members consist of Christina Rose, Patricia Bennett, Selene Hardison, Melody Stinson, Melody Harris, Darlene Lindsey and Kim Ingold. Ms. Christina Rose began the presentation by explaining that the ultimate goal of MYD CATS is for all stakeholders (school staff, parents, community and students) to exhibit personal responsibility. Ms. Rose said the philosophy is that school is viewed as a privilege. She said they now have one school rule: no one has the right to interfere with the learning, safety and well-being of others. She said they have two expectations: every student is to do what is expected and do it to the best of their ability. Ms. Rose said they have two components (steps and points). She stated that this program is very fair and everyone has a voice. Ms. Rose said there has been a tremendous difference in the classroom. Other committee members also shared their opinion of the MYD CATS Program. Ms. Hardison explained that she has a better rapport with the students. Ms. Ingold said the program has gotten the parents more involved. Ms. Bennett explained that the program has gone over very well with parents because they explain to the parent that students choose to make the decision to misbehave. Ms. Harris stated the program has helped the atmosphere at their school. She said it's not only the teacher's responsibility to teach, but it's the student's responsibility to learn. Ms. Rose explained that overall, before MYD CATS, AMS had a total of 543 suspensions and after MYD CATS, they had 120 suspensions. Furthermore, Ms. Rose said the committee meets on a

weekly basis and they discuss any issues that the staff may have. Mr. Owens said they are still tweaking the program and it will be an ongoing effort.
