# Minutes Anson County Board of Education Regular Meeting Monday, January 26, 2009, 5:30 p.m.

The Anson County Board of Education met in regular session Monday, January 26, 2009. All members were present except for the excused absence of Mrs. M. R. Bell. Others in attendance were Michael Freeman (Executive Director), Anne Hyatt (Board Assistant), Michael McLeod (Executive Director) and Frances Williamson (Deputy Superintendent).

## I. Call to Order

Board Chairperson Lisa Davis opened the meeting and welcomed all visitors. Superintendent Firn called the meeting to order.
