# Minutes Anson County Board of Education Regular Meeting Monday, July 27, 2009, 5:30 p.m.

The Anson County Board of Education met in regular session Monday, July 27, 2009. All members were present except for an excused absence from Altheria Patton and Daniel Wilson. Others in attendance were Mike Flake (Board Attorney), Michael Freeman (Executive Director) and Anne Hyatt Clerk to the Board of Education.

## I. Call to Order

Board Chairperson Lisa Davis opened the meeting and welcomed all visitors.

# IX. Superintendent's Report – See Attached

- Personnel/Budget Dr. Firn said the Governor has issued an Executive Order that
  has frozen all activity as it relates to spending any funds. Dr. Firn said we must
  receive permission from Raleigh to take any action to operate the school district
  other than those areas that have already been obligated or contracted. Dr. Firn
  prefaced that information with the budget piece because 89 percent of the budget is
  people and that includes not only compensation for salary but also for all benefits.
- AYP Results Dr. Firn said last year 3 of our schools made AYP; he said this year, 7 of our schools made AYP. Dr. Firn said all elementary schools except one made AYP this year. He said this is the largest number of schools since the No Child Left Behind Act was put in place and the reporting of Annual Yearly Progress took place. Dr. Firn said they are interpreting the results as validation and affirmation of the work that staff has been doing (not only this year, but building up to it from last year). Dr. Firn said the one elementary school that did not make AYP, still grew 17.6 percent (meaning they were just two targets/goals away from hitting 100 percent). Dr. Firn applauded the hard work at MES and WES and the gain those schools made. He said he is extremely pleased! Dr. Firn said he will be reporting in August (in greater detail), for all of the secondary schools, the growth and the targets that were met for their End of Course exams. He said this has to do with eligibility and there was an error in the students that should have been tested that were not tested. Dr. Firn said they have worked with Raleigh and rectified the problem and it does not reflect in any way issues with student performance. Dr. Firn feels the board will be equally pleased with the progress made in all of the secondary schools in each subject area.

• Extended Day (AES/PPES) – Dr. Firn explained that PPES is extending their day by 10 minutes to focus on literacy. Dr. Firn said they want to continue their drive on the work they are doing with reading in the area of comprehension and writing (Fast ForWord will also be extended). He also explained that AES is extending their day by 30 minutes to incorporate Fast ForWord and Head Sprout into their day.
