Minutes Anson County Board of Education Regular Meeting Monday, October 27, 2008, 5:30 p.m.

The Anson County Board of Education met in regular session Monday, October 27, 2008. All members were present. Others in attendance were Michael Flake (Board Attorney), Michael Freeman (Executive Director), Anne Hyatt (Board Assistant), Michael McLeod (Executive Director) and Frances Williamson (Deputy Superintendent).

I. Call to Order

Board Chairperson Lisa Davis opened the meeting and welcomed all visitors.

II. Invocation

Chairperson Davis asked M. R. Bell to give the Invocation.

III. Adopt Agenda

The agenda for today was unanimously adopted by the Board upon a motion by Russell Sikes, with a second by Lannie Allen. Motion carried.

IV. Approve Minutes (Regular Meeting 09-29-08)

M. R. Bell moved the minutes of the regular meeting of September 29, 2008, be approved. This motion was seconded by Altheria Patton, and unanimously approved.

V. Closed Session

Matters Related To Personnel

Chairperson Davis entertained a motion that the Board go into closed session for the purpose of considering a personnel action that involves an officer or employee of this Board pursuant to North Carolina General Statute 143.318.11(a) (6). This motion was made by M. R. Bell seconded by Lorenzo Steele and unanimously approved. The Board went into closed session at 5:32 p.m.

VI. Reconvene Open Session

Mary Crowder (parent of AMS student) expressed concern that her daughter was recently in trouble because of her jacket. She explained that her daughter wore the same jacket last year at Wadesboro Elementary and it was okay. Ms. Crowder said the jacket is orange and white with flowers on it. Chair Davis thanked Ms. Crowder and explained that someone will contact her to further discuss her concern.

Dannie Montgomery, Tammy Swearengin, Krista Herold and Maresa Phillips were present on behalf of the Anson County Association of Educator's to offer a \$500 check to the New Century Scholar's Program in honor of all Anson County School Employees.

IX. Superintendent's Report – See Attached

Discipline/Suspension (Mike McLeod)

- Michael Livingston asked about students returning to school during their suspension. Dr. Patton asked who was to ensure that did not happen.
 Dr. Firn said the process will be reviewed to make sure we have assurances that the process is being followed when a student is suspended.
- Mr. McLeod stated that the second round of McGrath Training (Bullying Training) is currently in process. Dr. Firn explained there will be a follow-up training from this training. He said this will give parents an opportunity to join staff/administration for a conversation about McGrath Training. Dr. Firn said he feels it is important for parents to hear what their students are hearing and to hear what the training is about.
 - Mr. McLeod said a date and time for this conversation has not been determined.

• AIG Program K-6 (Georgia Maner)

♦ Georgia Maner was present to speak about the AIG Program in K-6 grades. She said they are currently making sure that students are not repeating material and those students that already know the material can be moved on to a separate group. Mrs. Maner said they have asked the principals to give them names of individuals who would be responsible for monitoring this at the individual schools. She said they have individuals designated to monitor this program at AES, LES, WPS and WES. Mrs. Maner said she will be responsible for MES and PPES until the time someone is designated to monitor the program at those schools.

Mrs. Maner said the individuals responsible for monitoring this program have agreed to get licensure in gifted education. Dr. Firn explained that parents can speak with the principal if they have questions.

• Technology Plan (Jeanne Price)

◆ Jeanne Price was present to highlight items in the Technology Plan for Anson County Schools. Mrs. Price explained that NC Law mandates school systems to operate under the guidance of a Technology Plan and it must be in place in order for Anson County Schools to receive E-Rate Funding. She said the plan will need to be approved by our Board of Education and then by the State Board of Education. Mrs. Price said the plan is for a period of five years. Dr. Firn asked members to look over the plan and let Mrs. Price know if there are questions.

• Dress Code (Greg Firn)

♦ Superintendent Firn briefly gave the following reconsideration and recommendation as stated in his Superintendent's Report that is attached:

"I am withdrawing my proposed amendment to the Standard Uniform Policy. In its place, I ask the Board to return to the original Dress Code Policy for grades 9-12. With respect to grades K-8, I propose that administration will provide the Board of Education a plan for each school community to review with parents – all parents the purpose, intent, and expected outcome for dress according to the Board of Education's policy."
