# Anson County Board of Education Regular Meeting

## Thursday, June 30, 2016, 5:30 p.m. Charles Riddle Staff Development Center

The Anson County Board of Education met in regular session on Thursday, June 30, 2016. All members were present. #### I. Call to Order
