The Anson County Board of Education met in regular session on Monday, February 28, 2022. Call to Order

Face Coverings Policy

Dr. Truman made a motion to make masks optional for students and staff beginning March 7. The motion was seconded by Marilynn Bennett.

New Business

School of Choice for Kindergarten for 2022-2023

Lisa Davis made a motion to allow school of choice for rising Kindergarten students beginning with the 2022-2023 school year to let them choose a school in our district that fits their needs best. Dr. Truman seconded the motion and added that they must provide their own transportation. Mr. McLean said he needs the authority that if one school gets full, we need to cut off enrollment. Bobbie Little, Carol Gibson and Marilynn Bennett recused themselves from the vote. Those in favor of the motion were George Truman, Gay Lookabill, Lisa Davis, Mike Turner, Beulah Pratt and Frank Liles. Motion carried.
