The Anson County Board of Education met in a budget workshop and regular session on Monday, April 29, 2024. Call to Order

George Truman opened the workshop at 2:01 p.m. and welcomed everyone in attendance.

Invocation

Frank Liles gave the Invocation.

Adopt Agenda

George Truman amended the agenda to add Superintendent Evaluation to New Business. Lisa Davis asked to move Supplemental Funds for Teacher Compensation PRC071 and Participate Learning Master Services Agreement to New Business. Upon a motion by Carol Gibson, seconded by Marilynn Bennett, the board voted to adopt the agenda with the requested amendments. Motion carried.

Upon a motion by Lisa Davis, seconded by Frank Liles, the board approved the following consent items: personnel report, budget amendments and the proposed budget for 2024-2025. Motion carried.

New Business Items

Superintendent Evaluation

A motion was made by Frank Liles to accept the Superintendent's Evaluation Committee rating of 88% for the Superintendent's evaluation to be used for establishing the amount of the Superintendent's annual performance incentive. Dr. Truman stated the amount is to be prorated based on 11 of the 12 months. The motion was seconded by Carol Gibson and approved by the board. Motion carried.

Supplemental Funds for Teacher Compensation PRC071

The Supplemental Funds for Teacher Compensation PRC071 was approved by the board on a motion by Lisa Davis, seconded by Mike Turner. The motion carried.
