Anson County Board of Education Regular Meeting

Monday, November 19, 2018, 4:30 p.m. Anson County Schools' Administrative Office Board Room

The Anson County Board of Education met in regular session on Monday, November 19, 2018. All members were present. Bobbie Little arrived at 4:50 pm. Others in attendance were Michael Freeman (Superintendent), Howard McLean (Associate Superintendent), Marty Godwin (Assistant Superintendent), Holly Berry (Finance Officer), Mike Flake (Board Attorney) and Anne Hyatt (Board Clerk).

I. Call to Order

Chair George Truman opened the meeting and welcomed everyone in attendance.

II. Invocation

Mike Turner gave the Invocation.

III. Conflict of Interest Statement

In compliance with the requirements of Chapter 138A-15(e) of the State Government Ethics Act, Chair George Truman reminded Board Members of their duty to avoid conflicts of interest and appearances of conflicts of interest under Chapter 138A. There were no conflicts of interest communicated by the members. Chair Truman then requested that if, during the course of the meeting, members became aware of an actual or apparent conflict of interest that they bring the matter to his attention. He further explained it would then be the member's duty to abstain from participating in discussion and from voting on the matter.

Morven Elementary, Lilesville Elementary, Ansonville Elementary and Peachland-Polkton Elementary Schoosl were all recognized by the board for being named a NC Positive Behavior Intervention and Support Initiative (PBIS) Green Ribbon Award Winner.

Marilynn Bennett was recognized and presented a resolution from the board of education for her service as a board member over the last eight years.

XI. Superintendent's Report

Carol Gibson mentioned concerns about Anson Early College not having a licensed English teacher. Mr. Freeman stated he thinks there is a misunderstanding and will check into Ms. Gibson's report.

Facility/Current Projects Updates:

- PPES traffic pattern recommendation received approval by the state at no expense to the board of education. The extension of the parking lot, new exit road and sign relocation will be done during the summer months.
- Mr. Freeman will be working to get quotes to upgrade camera systems as each school.
- High school athletic complex project is going well and updates will continue.
- FEMA and Property Insurance info updates were shared with the board. Mrs. Berry confirmed three property insurance claims were submitted and approved for Anson Middle School, Anson High School and Peachland-Polkton Elementary School.

Dr. Truman asked what the next steps will be for a new middle school. Mr. Freeman said they will soon post a request for qualifications to work with an architect on a school design. He further explained phase one studies will be reviewed and we will begin getting estimates on what it will cost to build a new middle school.
